The Board Discussed the Following Items:


- Random Student Drug Testing

- Two (2) Year Strategic Plan Budget Analysis

- Mike LaFavers, Superintendent, and David Morris, Chief Finance Officer, presented a two (2) year strategic plan budget analysis. The plan proposes the purchase of three (3) buses and a two percent (2%) raise for employees in each of the next two (2) years. The plan also includes tax exonerations estimates, section 7 adjustments, staffing adjustments, growth factor, and CERS increases.
