The Board Discussed the Following Items:

Boyle County Middle School Design:

Architect Tony Thomas, reported on performing arts center versus auditorium. The performing arts center is more expensive to build than a traditional auditorium. Mr. Thomas reported that the Board could build the shell of a 750 seat performing arts center and bid alternates for amenities.

The Board reviewed four (4) preliminary traffic pattern option to connect the new Boyle County Middle School to the main campus. The Board asked to the administration to work on versions of Plan 2 that was presented. This decision would need to be made within the next four (4) to six (6) months.

The Board discussed instructional spaces for the new Boyle County Middle School. The Board discussed intrinsic spaces and learning environment.

Architect Tony Thomas, reviewed a draft layout based on the High Impact Team's vision for communal spaces and building layout. Mr. Thomas also reported on the change of square footage for the building and cost projections.

The Board discussed options for project management for the new Boyle County Middle School construction project, including the district possibly creating a new district position to manage/oversee the construction project.
